# FPI MANAGEMENT

#### What to bring

For your initial certification appointment All adult applicants will need to be present.

Documents to bring are as follows:

- Original Valid Identification
- Original Social Security Cards for all applicants including minor household members
- Original Birth Certificates for all minor applicants
- 6 months of the most recent bank statements from checking accounts
- Most recent, bank statements for Savings, Money Market, CD, IRA, and 401K retirement plans
- 3 Months of consecutive paystubs from employer(s)
- If You Have any prepaid accounts (Venmo, Chime, Cash App, etc.) Please Provide current statement
- Current Benefit Award Letter (Social Security, SSI, Unemployment, GA, CalWORKs, Pension)
- If you claimed AUSD, County or City of Alameda preferences please bring proof
- Additionally, if you are <u>self-employed</u> i.e., Doordash, Grubhub, Uber, Uber Eats, Postmates, Instacart, you will need to bring your current payouts and expenses beginning January 1, 2022. You will also need to bring your 2022 tax return. If your 2022 return shows you collected unemployment you will also need to present proof that you are no longer receiving unemployment income.
